This position is accountable for reviewing proposed transportation improvements for potential impacts to protected natural resources. This position ensures departmental compliance with the laws, rules, and regulations protecting natural resources including wetlands and endangered and threatened species.

This position reports to the Natural Resources Unit Manager. There are no subordinates reporting to this position.

This position functions within a statewide program where a large number of environmental survey requests (ESRs) for proposed improvements are received from the Illinois Department of Transportation (IDOT) district offices, county governments, and other department offices. This position works in a complex environment due to the necessary integration of the many requirements of the National Environmental Policy Act (NEPA), related federal (Clean Water Act, Executive Order on Wetland Protection, Wild and Scenic Rivers Act, among others) and state (Illinois Interagency Wetland Policy Act of 1989, Nature Preserves Act, among others) environmental laws, and interagency agreements. This position adheres to the various regulations, policies, and procedures promulgated by those agencies with which we coordinate (Illinois Department of Natural Resources, U.S. Fish and Wildlife Service) or which have regulatory jurisdiction over certain aspects of project implementation (U.S. Army Corps of Engineers, U.S. Environmental Protection Agency [EPA], Illinois EPA, and the Federal Highway Administration [FHWA]).

The challenge facing the incumbent is applying or integrating the requirements of the NEPA, Clean Water Act, and Endangered Species Act, among others, to the highway development process to ensure compliance. Typical problems for the incumbent are determining which laws and regulations apply to a given project, establishing priorities within the diverse projects, and completing reviews within defined timeframes.

The incumbent provides natural resources expertise to all highway districts and offices of the department. S/He operates the biological component of the Environmental Survey Program. The incumbent reviews environmental reports. S/He disseminates technical environmental information to the appropriate office in the department. S/He prepares and updates sections of the Natural Resources Manual and the Bureau of Design and Environment (BDE) Manual. The incumbent stays abreast of environmental laws, regulations, policies, and procedures.

(Job Responsibilities continued)

The incumbent is given general latitude in accomplishing his/her tasks. Non-routine or complicated problems are referred to the Natural Resources Unit Manager for resolution. S/He is constrained by applicable departmental/state/federal regulations.

Internally, the incumbent is in frequent contact with district environmental coordinators, design squad leaders, project coordinators, and natural resource personnel within the Location and Environment Section. S/He is in contact with location field engineers for the purpose of obtaining and distributing wetland resource information. Externally, the incumbent is in contact with contractual survey personnel, coordinators within natural resource and regulatory agencies, and the FHWA. Occasional statewide travel with overnight stays is required.

The effectiveness of this position can be measured by the timeliness and quality of expertise in operating the biological component of the Environmental Survey Program. This includes the review of ESRs, research, report writing, and effective coordination of department projects with outside resource agencies
